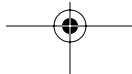
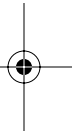
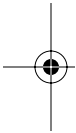


Dedication

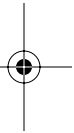
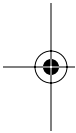

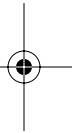




Authors
